

**DIRECTIONS**

- (1) If there are a number of substantial holders with similar or related relevant interests (eg. a corporation and its related corporations, or the manager and trustee of an equity trust), the names could be included in an annexure to the form. - (3) See the definition of "relevant interest" in sections 608 and 671B(7) of the Corporations Act 2001.
